

We Respect your Privacy

1.1 Karishma Nana Chiropractic respects your right to privacy and is committed to safeguard the privacy of our customers and website visitors. We adhere to the Data Protection Act 2018. The policy sets out how we collect and treat your personal information. ("Personal information" is information we hold which is identifiable as being about you)

Collection of personal information

2.1 Karishma Nana Chiropractic, will from time to time, receive and store personal information you enter onto our website, provided to us directly or given to us in other forms.

2.2 You may provide basic information such as your name, phone number, address and email address to enable us to send information and provide updates. How we collect your personal information

Use of your personal information
